In calendar year 2020, All Blessings Flow acquired over 124,000 pounds of used medical equipment and medical supplies valued at \$917,313 which was carefully cleaned and refurbished for redistribution. During the year, we distributed 11, 670 pieces of used medical equipment and supplies, free-of-charge to 3,175 uninsured or under-insured disabled adults and children coming from 50 different cities and counties within the Commonwealth of Virginia and beyond.

Explanation: All Blessings Flow filed Form 8868, the application for an automatic extension of time to file, giving us until November 15, 2021 to file our calendar year 2020 Form 990. However, like so many other small non-profit organizations, we were struck hard by the pandemic in 2020. As a health services organization, we were committed to maintaining our program services to help our low-income clients with disabilities, many of who were affected severely by the pandemic. We also encouraged many of our volunteers with higher COVID risk levels to stay home, thus reducing our workforce by 75%. Unfortunately, this reduction meant those of us remaining were working much harder to keep up with the demand. During this time, we were humbled to have been selected by The United Way as the "Above and Beyond Nonprofit in Charlottesville-Albemarle" for our efforts to remain open and continue to serve our community during the pandemic. In fact, despite the new protocols and limitations, 2020 was our busiest year to date, as we helped over 3,100 families. As a result of the pandemic, our volunteer CPA who normally files our tax returns became extremely busy with her full-time tax practice - filing applications for COVID-relief programs and loans, etc. She became so busy with her paying clients, that her focus was no longer on her responsibilities as a volunteer to file the 2020 tax return for All Blessings Flow. Unfortunately, we were not as observant of the filing deadline as we should have been due to our reduced workforce and COVID limitations. After many months of waiting for our volunteer CPA to finish the 2020 tax return, we finally decided to take matters into our own hands. We have appointed a new volunteer, a retired accountant, to prepare the Form 990 tax returns and to establish new guidelines and procedures to prevent any delinquent tax filings in the future. Consequently, I am confident that we will file our 2021 Form 990 tax return by the extended deadline. I believe this explanation is a reasonable cause for our delinquent Form 990 and I respectfully request that you consider the extenuating circumstances under which we have operated for the past 27 months.
