Civic Digital Fellowship:The Civic Digital Fellowship is a 10-week-long internship program for software engineering, data science,product management, and design studentsboth at the undergraduate and graduate levelto solve innovation challenges in theUnited States federal government. Fellows receive a living stipend, housing, and roundtrip domestic travel to and from Washington, D.C., as well as exposure to the civic technology ecosystem through professional programming. For its Summer 2020 cycle, the Civic Digital Fellowship received 895 applications from 205 colleges and universities. 62 Fellows were selected and placed at eight federal agencies to improve their technical capabilities. After the Fellowship,Fellows reported feeling more prepared to enter the technology workforce upon graduation, with significant increases in the proportions feeling moderately prepared (from 41% to 51%) and extremely prepared (from 11% to 24%).

First Act Fund:The First Act Fund provides catalytic funding and support to mission-driven young people with early-stage ideas to create impact with technology. During the 2020 fiscal year, Coding it Forward provided nine \$10,000 grants to nine teams of innovators. In addition to the grant, these grantees received guidance from the Coding it Forward team in the form of regular check-ins and connections to the organizations network and mentor directory. These grants allowed teams to make initial investments in their team growth and product development, form partnerships with research groups and accelerators, and receive additional external funding opportunities valued at over \$5 million.
