THE DEBORAH PROJECT, FOUNDED BY HARVARD LAW SCHOOL PROFESSOR JESSE FRIED AND STAFFED BY EXPERIENCED VOLUNTEER AND STAFF ATTORNEYS, PROVIDES LEGAL ASSISTANCE ON A PRO BONO BASIS TO THOSE BEING DISCRIMINATED AGAINST IN EDUCATIONAL SETTINGS, EITHER BECAUSE THEY ARE JEWISH AND/OR PRO-ISRAEL. THE AIM OF THE DEBORAH PROJECT IS TO USE LEGAL SKILLS AND TOOLS TO UNCOVER, PUBLICIZE AND DISMANTLE ANTISEMITIC ABUSES IN EDUCATIONAL SYSTEMS, WITH THE AIM OF BRINGING WRONGDOERS TO JUSTICE AND DETERRING FUTURE ABUSES.

28 THE DEBORAH PROJECT'S MISSION AND OVERALL OBJECTIVE IS TO PROVIDE PRO BONO LEGAL SERVICES TO PEOPLE AND INSTITUTIONS VICTIMIZED BY ANTI-SEMITISM AND/OR ANTI-ZIONISM IN U.S. EDUCATIONAL INSTITUTIONS. DURING 2020, THE DEBORAH PROJECT'S PERSONNEL SERVED AS LEAD COUNSEL IN ONE PENDING CASE BRONNER V. AMERICAN STUDIES ASSOCIATION, WHICH WAS THEN PENDING IN THE COURT OF APPEALS FOR THE DISTRICT OF COLUMBIA. WE BRIEFED AND THEN ARGUED THIS APPEAL, WHICH ADDRESSED THE QUESTION WHETHER THE CASE, IN WHICH THE DEBORAH PROJECT REPRESENTS THE FOUR PLAINTIFFS, CAN PROCEED. WE ADVISED OUR CLIENTS ABOUT THE STATUS OF THE APPEAL. IN SEPTEMBER OF 2021 WE LEARNED THAT WE HAD PREVAILED ON THIS APPEAL, AND THAT THE CASE WILL PROCEED.DEBORAH PROJECT PRESIDENT JEROME MARCUS SERVED AS ONE OF THE COUNSEL FOR A GROUP OF LAW PROFESSORS WHO APPEARED AS FRIENDS OF THE COURT IN AMAWI V. PAXTON, PENDING IN THE UNITED STATES COURT OF APPEALS FOR THE FIFTH CIRCUIT. ON APRIL 27, 2020, WE LEARNED THAT ONE OF THE ARGUMENTS WE HAD ADVANCED WAS ADOPTED AS THE BASIS FOR THE COURT'S DECISION IN THAT CASE.DEBORAH PROJECT PRESIDENT ENTERED HIS APPEARANCE AS ONE OF THE COUNSEL FOR PLAINTIFF IN NEWMAN V. POINT PARK UNIVERSITY, A CASE PENDING IN THE UNITED STATES DISTRICT COURT FOR THE WESTERN DISTRICT OF PENNSYLVANIA. DISCOVERY IS ONGOING IN THAT CASE.DURING 2020 THE DEBORAH PROJECT PERSONNEL ALSO EVALUATED OTHER POTENTIAL CLAIMS RELATING TO ANT-SEMITISM AND ANI-ZIONISM ON COLLEGE CAMPUSES AND OTHER EDUCATIONAL INSTITUTIONS.
