Worker Organizing Program In 2020, our Worker Organizing Department launched a COVID-19 Service Workers Relief Fund, to which 250,000 workers applied for relief. We were able to provide cash relief to nearly 50,000 workers and offered legal services and financial counseling, as well as the opportunity to engage in digital town hall meetings with elected officials and other opportunities to share their concerns and needs, to all who applied. In the fall of 2020, we also conducted voter outreach to these worker relief fund applicants, providing them with information about how to register to vote and how to vote during the pandemic. We also conducted multiple digital and live press events, uplifting these workers needs and voices to the press.
