AMPLIFY provides administrative and operational support tailored training programs and funding to a growing list of partner-organizations focused on improving the lives of girls and women across the world. In 2020 AMPLIFY has provided 30 different training opportunities on resource mobilization monitoring and evaluation and strategic planning to 50 organizations. In addition to in person and online trainings we have provided one-on-one tailored support to individual organizations to help support their growth and development. AMPLIFY is committed to developing communities of practice in specific countries across Eastern Africa based on research. In 2020 AMPLIFY raised and disbursed grants to support local organizations as they battled COVID-19.

DEMONSTRATE: AMPLIFY works collaboratively with CDOs to develop research that is relevant and supports the development of CDOS. AMPLIFY has developed an initial survey on agency of adolescent girls in Eastern Africa and continues to develop research frameworks in partnership with CDOs. AMPLIFY provides M&E training and support to partner organizations. AMPLIFY provides financial support to partner organizations as they participate in research and developing their M&E teams. AMPLIFY has produced a number of research papers on their work. AMPLIFY will continue to share their Agency Tool with partners across Eastern Africa and will continue to support their research agendas.

SHIFT: AMPLIFY wishes to improve and shift the current global development narrative to decrease inequities in race gender and geography in global development practice. AMPLIFY brings partners together twice a year to meet and develop the strategic direction of AMPLIFY and the issues they hope to tackle. In addition to regional meetings AMPLIFY hosts country based convenings and one on one connections between partners.
