WE DISBURSE GRANTS, IDENTIFY GAPS, DEVELOP COMMUNICATIONS RESEARCH TO INFORM THE MOVEMENTS AND COORDINATE EVENTS AND CONVENINGS TO ENCOURAGE INVESTMENT AND ACTION FROM OTHERS. YEARS OF RESEARCH SHOW THAT WHEN GIVEN UNRESTRICTED PAYMENTS, RECIPIENTS ARE ABLE TO PULL THEMSELVES OUT OF POVERTY AND CREATE ECONOMIC STABILITY FOR THEMSELVES AND THEIR FAMILIES. THAT'S WHY WE HAVE INVESTED IN BOTH ON-THE-GROUND AND POLICY EFFORTS TO PUT MORE CASH IN THE POCKETS OF AMERICANS WHO NEED IT MOST.
