SKY ISLAND ALLIANCE INSPIRES AND EMPOWERS PEOPLE TO CONNECT WITH AND CARE FOR THE WILDLIFE, WATER AND LANDS OF THE SKY ISLANDS. IN 2020 WE ENGAGED HUNDREDS OF VOLUNTEERS, STUDENTS, AND PARTNERS IN THE U.S. AND MEXICO IN COMMUNITY SCIENCE AND CONSERVATION PROJECTS TO PROTECT AND ENHANCE CONNECTED OPEN SPACE AND WATER AT SPRINGS AND STREAMS. WE INVENTORIED 256 SPRINGS IN ARIZONA AND SONORA THROUGH SPRING SEEKER AND RESTORED WETLAND AND STREAMSIDE HABITAT. WE USED WILDLIFE CAMERAS TO DOCUMENT THE COMMUNITY OF WILDLIFE UNDER THREAT FROM BORDER WALL CONSTRUCTION THROUGH OUR BORDER WILDLIFE STUDY AS WELL AS THE SEASONAL PRESENCE OF 43 SPECIES OF WILDLIFE THROUGH FOTOFAUNA.
