LEADERS BEGIN WITH A MULTI-DAY TRAINING ON CLIMATE SCIENCE, COMMUNICATION, AND ACTIVISM LED BY FORMER US VICE PRESIDENT AL GORE. AFTER COMPLETING THE TRAINING, CLIMATE REALITY LEADERS RETURN THEIR COMMUNITIES TO ENGAGE THEIR PEERS USING A WIDE ARRAY OF ADVOCACY TOOLS AND ACTIVITIES.
