CUSTOMERS ARE REFERRED TO CASCADE CONNECTIONS THROUGH THE DEVELOPMENTAL DISABILITIES ADMINISTRATION, AGING AND ADULT SERVICES, AND PRIVATE PAY CONTRACTS.
