PBI works to open a space for peace in which conflicts can be dealt with non-violently. We use a strategy of international presence and concern that supports local initiatives and contributes to developing a culture of peace and justice. We act on request of local non-violent groups working for human rights and social change in regions where there is oppression and conflict.

 COLOMBIA PROJECT: PBI has been working in Colombia since 1994 using a comprehensive protection model based on four complementary work streams. In 2020, the team accompanied 12 organisations, three human rights defenders and one displaced community in resistance, resulting in a total of 870 people being directly accompanied. The project organised 102 advocacy meetings with national authorities and facilitated 111 meetings to give human rights defenders access to the international community. The project carried out more than 450 activities to disseminate information about the work and situation of human rights defenders. To support civil society and contribute to the rebuilding of the social fabric, the project held 66 meetings and facilitated 20 one-to-two day workshops over a total of 71 days. The project has teams based in Bogotá, Barrancabermeja and Apartadó.

 GUATEMALA PROJECT: A team of seven international volunteers accompanied 217 human rights defenders working on environment and land rights, impunity and globalisation. Volunteers are based in Guatemala City and travel to other areas of the country. The project provided 136 accompaniments, held 98 visits and meetings with defenders to provide moral support and practical advice around their protection needs and facilitated seven workshops on protective strategies for 139 defenders (three for women human rights defenders only). The project also monitored eight demonstrations, three speaker tours in Europe and a meeting between defenders and the international community in Guatemala. The project met local, regional and national authorities 50 times and held 37 meetings with the diplomatic corps, the UN, other NGOs and international coalitions and networks.

 MEXICO PROJECT: With eleven international volunteers based in Mexico City, Oaxaca and Chihuahua, the project accompanied defenders working on impunity, women's rights, indigenous rights and environmental protection, with direct impact over a wide range of accompanied organisations and civil society spaces. Due to the COVID-19 pandemic, the two regional teams of volunteers left Mexico in late March. Most of them continued to work remotely from their home countries until the end of May, and four worked remotely until the end of 2020, focusing on advocacy, communication and protection activities. The central coordination office in Mexico City maintained its core activities, adapting to the new work dynamics for the remainder of the year. The project currently accompanies three organisations and two civil society networks in the states of Puebla, Chihuahua, Coahuila and Mexico City. The project also started a capacity-building process with five new organisations through an agreement with the Semillas Fund organisation that works to improve the situation and condition of women in Mexico. 69 people benefited from the international accompaniment provided by the project. Other civil society organisations received punctual support from PBI Mexico through requests for specific activities.

 PBI NICARAGUA IN COSTA RICA: In 2020, PBI provided capacity development to the Nicaraguan Campesino Movement who supported the civil society sectors affected by State repression in 2018. Our support focused on rebuilding the social fabric of the organisation to enable its members to continue their work in defence of human rights. Through online workshops designed to support the consolidation and collective self-care of the group we were able to reach defenders living in exile as well as defenders who remain in Nicaragua.

 PBI INDONESIA: Three English for Human Rights Advocacy courses were given to Indonesian human rights defenders with the help of 27 international volunteers as virtual language buddies. The situation of defenders during the pandemic was monitored and regular updates were given to civil society and other stakeholders. The Indonesia Project concluded a series of needs assessments and other studies to launch an exploratory regional project for Southeast Asia.

 PBI HONDURAS: Ten international volunteers carried out 29 accompaniments, held 86 visits and meetings with defenders, and five observation visits with six organisations or human rights defenders in Honduras working on land and environmental rights, indigenous rights, women's rights, rights to freedom of expression and association, and LGBT rights. The project directly accompanied 113 human rights defenders (around 50% were women). The number of indirect beneficiaries - those supported or advised by defenders we accompanied - was around 28,500. Our accompaniment activities weren't limited to the capital Tegucigalpa as volunteers travelled to several departments, especially La Paz, Yoro, Atlántida, Cortés, Olancho, Comayagua and Santa Bárbara, to accompany defenders, observe civil society activities, meet with local authorities and visit communities and organisations' offices. PBI Honduras held 48 meetings with Honduran civil society organisations, 43 meetings with Honduran authorities and 48 meetings with actors of the international community, including members of the diplomatic corps, the UN, the EU, foreign ministries, parliamentarians and international NGOs. In addition, we organised a virtual international speaking tour of accompanied defenders. The project continued to consolidate its capacity-building programme, facilitating 20 security and protection workshops, either virtually or in person, to 141 defenders (72 women), both in Tegucigalpa and in other parts of the country.

 INTERNATIONAL SECRETARIAT (ISEC): In 2020, ISEC provided ongoing coordination and support to the global organisation, oversaw strategic planning and development, ensured that PBI met with its external legal, financial and compliance obligations, and coordinated global communications, fundraising and advocacy strategies. ISEC also coordinated the organisation's approach to managing the COVID-19 crisis and its impact on field operations. ISEC oversaw the creation of a Project Exploration Committee, which has started examining the viability of new projects in Southeast Asia. The Secretariat also oversaw the launch of a short-term project in Costa Rica focused on providing psychosocial support and capacity development to exiled Nicaraguan human rights defenders.
