LEADERSHIP DEVELOPMENT. In 2020, WCAN ERF, through grants to related organization WCAN, supported work to train grassroots leaders. Organizers hold monthly community meetings where leaders work with other community members to strategize campaigns to address issues affecting their communities develop the skills to carry them out. Leaders mobilized 307 community members to call or email their policy maker to share their stories about why better access to dental therapists is needed. In the fall, with exploding numbers of Covid-19 cases in the state prisons, leaders organized a mock funeral outside the Governors mansion to highlight the increased risk of contracting Covid to both staff inmates due to the inability to properly social distance. The mock funeral and the stories from family members, sharing the impact of a loved ones incarceration, can shift the public narrative about incarceration since media routinely only use images of people behind bars when presenting stories about incarceration.

PUBLIC OUTREACH EDUCATION. In 2020, WCAN ERF, through grants to related organization WCAN, conducted public outreach tabling outside of 6 grocery stores in the Seattle area educating individuals about the health care system, registering voters and gathering signatures in support of universal health care. We had 2,753 conversations, gathered 2,322 signatures in support of universal health care, and registered 297 people to vote. In the general election WCAN ERF conducted Get-Out-The-Vote work in districts with low propensity for voting by educating people on deadlines and ballot box locations, and reminding them that a stamp is no longer required to return their ballot. Our GOTV efforts included knocking on 8,357 doors, having 1,093 conversations and got 1,071 pledges to vote. In response to the murder of George Floyd, WCAN ERF organized a rally attended by over 1,000 in Olympia with various speakers representing black and indigenous voices who shared their stories of police brutality.

FIRELANDS TOGETHER. Throughout the COVID-19 pandemic, the communities that Firelands serves-- rural essential workers and precarious families-- have suffered from high exposure to COVID-19 -- unemployment, financial crisis and risk of homelessness. In order to address these growing needs, Firelands formed an all-Latina, Spanish-speaking team of 11 and directly supported over 200 immigrant families in filling out applications for assistance. In addition, Firelands organized a caravan for food drop-offs. They hosted three public events where thousands of masks and diapers were distributed. Hundreds of food boxes and sanitizer were provided for 600 families.
