SMASH SCHOLARS START IN THE PROGRAM IN 9TH GRADE, CONTINUING THROUGH THEIR SENIOR YEAR. OVER THE THREE-YEAR PERIOD, SCHOLARS RECEIVE MORE THAN 1,000 HOURS OF STEM COURSEWORK, MENTORSHIP, AND LEADERSHIP DEVELOPMENT.PRIMARY PROGRAMMING IS HELD DURING THE SUMMER, WHERE SMASH SCHOLARS LIVE ON A COLLEGE CAMPUS FOR 5 WEEKS EACH SUMMER FOR THREE YEARS. OUR UNIVERSITY PARTNERS HOSTING OUR SCHOLARS EACH YEAR INCLUDE: UC BERKELEY, STANFORD UNIVERSITY, UC DAVIS, UCLA, MOREHOUSE COLLEGE, WAYNE STATE UNIVERSITY, ILLINOIS INSTITUTE OF TECHNOLOGY, NORTHEASTERN UNIVERSITY, UNIVERSITY OF PENNSYLVANIA, AND UNIVERSITY OF MICHIGAN.DURING THE ACADEMIC YEAR, ON SATURDAYS, SMASH SCHOLARS PARTICIPATE IN COLLEGE SUCCESS WORKSHOPS, WHICH COVER TOPICS SUCH AS FINANCIAL AID, COLLEGE VISITS, AND COLLEGE FIT.
