SCHEDLUE R SUPPLEMENTAL	As explained elsewhere in Form 990 and Schedule O, the ACLU NC Foundation is a California public benefit corporation described in Section 501(c)(3) and classified as a public charity. Directors of the ACLU NC Foundation board are appointed by the American Civil Liberties Union of Northern California (ACLU NC Union), a California mutual benefit corporation described in Section 501(c)(4). The ACLU NC Union, in turn, is affiliated with the American Civil Liberties Union, Inc. (ACLU National), a District of Columbia not-for-profit corporation described in Section 501(c)(4). To reduce costs and maximize efficiency the ACLU NC Union and the ACLU NC Foundation share certain resources pursuant to a negotiated agreement. The agreement requires the ACLU NC Union to reimburse the Foundations expenses at a rate that is no less than the Unions fair share of such expenses, plus the Foundations cost of administering such sharing of resources and allocation of expenses, on a monthly basis, for any resources belonging to the ACLU NC Foundation that the ACLU NC Union uses in connection with the conduct of its activities, and the ACLU NC Foundation is permitted to pay no more than fair market value for any resources belonging to the ACLU NC Union that the ACLU NC Foundation uses in connection with the conduct of its activities. All shared resources, including office space, personnel, equipment, overhead, etc., are accounted for, and, as appropriate, paid for under the agreement.
