ACQUISITION OF 530-ACRE ALDER CREEK SECURES PROTECTION FOR THE WORLD'S LARGEST REMAINING PRIVATELY-OWNED GIANT SEQUOIA PROPERTY. THE LEAGUE WILL OWN IT FOR FIVE TO TEN YEARS BEFORE INCORPORATING IT INTO THE GIANT SEQUOIA NATIONAL MONUMENT. FEE ACQUISITION OF THE MISTIER AND NESSET PROPERTIES ALONG FRESHWATER RIDGE, WHICH SEPARATES REDWOOD NATIONAL PARK AND HUMBOLDT LAGOONS STATE PARK, COMBINED WITH THE NEARBY LEAGUE-HELD BATHURST AND MILLER PROPERTIES, SECURES A 90-ACRE NATURAL CORRIDOR, SAFEGUARDING MIXED-CONIFER FOREST AND WILDLIFE HABITAT.
