CAMPUSES LOCATED IN PALO ALTO AND SAN JOSE, CALIFORNIA, PROVIDE TRANSFORMATIVE EDUCATION IN A CARING, SETTING WHERE CHILDREN WITH SEVERE EMOTIONAL AND BEHAVIORAL ISSUES REENGAGE IN LEARNING, AND DEVELOP THE POSITIVE BEHAVIORS NECESSARY TO TRANSITION BACK TO A DISTRICT SCHOOL. EBC SCHOOLS EMPLOY A COMBINATION OF THERAPEUTIC, ACADEMIC AND ENRICHMENT OPPORTUNITIES TO CREATE AN INDIVIDUALIZED COMPREHENSIVE PLAN FOR EACH STUDENT. WHEN A STUDENT IS EQUIPPED EMOTIONALLY AND EDUCATIONALLY TO RETURN TO LOCAL PUBLIC SCHOOL, THE STUDENT IS GRADUALLY TRANSITIONED TO ENSURE SUCCESSFUL REINTEGRATION, GENERALLY WITHIN THREE YEARS. SAND HILL SCHOOL IS AN INDEPENDENT DAY SCHOOL CAMPUS LOCATED IN PALO ALTO.
