ACCORDING TO THE 2018 SONOMA COUNTY POINT-IN-TIME HOMELESS CENSUS AND SURVEY, YOUTH HOMELESSNESS REPRESENTS MORE THAN 20% OF THE TOTAL HOMELESS POPULATION IN SONOMA COUNTY. YOUNG ADULTS ARE HAVING A HARDER TIME FINDING AFFORDABLE HOUSING AND JOBS. OVERALL, NEARLY 1 IN 4 HOMELESS PEOPLE IN SONOMA COUNTY ARE UNDER THE AGE OF 25.
