ANIMAL WELFARE: THE JANE GOODALL INSTITUTE (JGI) ENSURES THE WELFARE OF CHIMPANZEES AND OTHER ANIMALS THROUGH BEST-IN-CLASS REHABILITATION AND SANCTUARY CARE/STANDARDS INCLUDING OUR TCHIMPOUNGA CHIMPANZEE REHABILITATION CENTER, ONE OF THE LARGEST CHIMPANZEE SANCTUARIES IN AFRICA, AND FACILITIES AROUND THE WORLD, GLOBAL ADVOCACY, AND OUR UNIQUE TRIANGLE APPROACH OF WORK WITH LAW ENFORCEMENT, EDUCATION, AND SANCTUARY CARE.
