The mission of the Disability Rights Education and Defense Fund is to advance the civil and human rights of people with disabilities through legal advocacy, training, education, and public policy and legislative development.

Legal Advocacy - DREDF represents people with disabilities and organizations serving people with disabilities on impact cases that further civil rights for people with disabilities. In 2020, we committed significant resources to ensure that disabled people disabled people and their families did not experience illegal discrimination when accessing health care and other services during the COVID-19 pandemic. We worked to ensure that federal and state laws that prohibit disability discrimination were enforced so that people with disabilities had an equal opportunity to stay safe and to receive life-sustaining treatment during the COVID-19 pandemic. DREDF frequently serves as co-counsel and files amicus briefs in the appellate courts and the US Supreme Court. In May 2020, we joined 17 other national disability rights organizations in an amicus brief in California v. Texas, a case heard by the Supreme Court in the fall of 2020. The brief supports 21 states that are defending the constitutionality of the Affordable Care Act (ACA), and provides evidence of how Congress, in the ACA, clearly and intentionally strengthened comprehensive and affordable health coverage for people with disabilities.DREDF and co-counsel filed a federal lawsuit on behalf of people with serious mental health disabilities against Alameda County and Alameda Health System. The lawsuit challenges the Countys failures to provide adequate community-based services to people with serious mental health disabilities causing unnecessarily cycling through jail and other locked institutions.As an IOLTA Support Center, DREDF provided significant legal training, legal technical assistance, and advocacy support to California IOLTA legal services programs on disability civil rights. We conducted statewide trainings for over 200 legal aid attorneys on the rights of disabled people, examining common disability access barriers, relevant disability rights, and best practices for tackling key issues. The trainings also covered new law related to eviction prevention during the COVID-19 pandemic.

National Disability Policy and Research - DREDF conducts research, monitors public policy development and provides technical assistance on issues affecting the civil and human rights of people with disabilities and advocates for the rights of people with disabilities.In 2020, much of our policy and research work focused on ensuring that public funding, public policy and legislation developed to address the devastating impact of the Coronavirus addressed the needs of disabled people and their families. Our research included case studies on promising housing practices that promote affordable, accessible housing and help people with disabilities move from institutions to homes in the community.

Technical Assistance on the Americans with Disabilities Act - DREDF has long been recognized for its expertise on the ADA. There was continued dissemination of information and referral services and training on the ADA to individuals with disabilities and advocates.
