Protect LGBTQ youth from so-called "conversion therapy" through NCLR's Born Perfect campaign by: helping state legislatures, local governments, and equality groups pass bills banning conversion therapy through assistance in drafting, advocating for, and executing new successful state and local laws that prohibit these practices; defending successful state and local laws against constitutional challenges; representing survivors in and out of court in holding conversion therapy practitioners accountable for the harm they cause; working with state agencies to address conversion therapy through regulation and executive action; educating parents and the public about the dangers of these practices through the Born Perfect website, workshops, and media outlets; working with families and religious leaders to end religious conversion-therapy counseling; and building a rapidly growing network of conversion therapy survivors empowered to speak about their stories to families, professionals who work with youth, and the media.
