Litigated to Protect People from Toxic Chemicals and Heavy Metals:CEH initiated new litigation against 55 companies. Many of these cases relate to cancer-causing hexavalent chromium in leather gloves and shoes and will lead to legal agreements in 2021.CEH reached a final settlement with a metal processing company in Paramount, CA to hold them accountable for emitting carcinogenic hexavalent chromium into the air. The agreement also allocates additional funding to residents of Paramount to get the resources needed for home air filtration systems.Other CEH legal agreements set strict limits on the amount of heavy metals and toxic chemicals in products including: jewelry, brass mouthpieces, potato and veggie chips, French fries, and animal crackers.

Shifted the market away from harmful endocrine disrupting chemicals (EDCs) in Food:Tested foodware for harmful fluorinated chemicals, adding 42 additional items to our popular web-based database, bringing database total to 328 disposable food containers. Presented a webinar on EDCs in disposable foodware and how K-12 schools can make the transition from single-use foodware to healthy, sustainable reusables.Developed resources to help businesses and schools procure safer foodware free from harmful EDCs.Helped secure the University of California systems restriction on EDCs in compostable foodware, impacting 9 public universities across the state of California.Launched the pilot of a third-party single-use foodware certification to help purchasers find and switch to healthy foodware products.

Develop and Advocate for Sound Public Policy to Protect People from Toxic Chemicals:Co-led a multi-day event with partners in North Carolina to call for action and educate legislators, advocates, and community members about the contamination of per- and polyfluoroalkyl substances known as PFAS chemicals in the air, soil, rivers, and drinking water in North Carolina communities.Submitted a petition to the Environmental Protection Agency (EPA) demanding that it address PFAS pollution in Cape Fear communities by requiring The Chemours Company to fund comprehensive health and environmental effects testing on 54 PFAS chemicals manufactured at its production facility in Fayetteville.Co-led the Policy and Legal Hub of the Cancer-Free Economy Network. Convened a diverse group of advocates (1) to provide legal and policy guidance to the network and (2) to develop and implement strategies to protect people from toxic chemicals.
