1 Briefly describe the organization's mission:

Californians for Justice (CFJ) is a statewide grassroots organization working for racial justice by building the power of youth, communities of color, immigrants, low-income families, and LGBTQ communities. Since our founding in 1996, we have centered Black, Latinx, AAPI youth and other historically vulnerable communities to ensure their perspectives drive our work and are embedded in our organizational DNA. Led by students, we organize to advance educational justice as the path to improving our social, economic, and political conditions. We achieve our goals through three core strategies: 1) Organizing and Advocacy: Leading campaigns to improve school systems and culture for low income students of color; 2) Alliance Building: Growing the leadership of alliances to win campaigns and hold decision-makers accountable, and 3) Leadership Development: Deepening the analysis and skills of youth leaders so they can advocate for student-centered reforms and hold decision-makers accountable.

Advancing racial justice through Relationship Centered Schools & Building power across the state: CFJ San Jose worked with community allies and teachers to end police and School Resource Officer contracts, resulting in \$900,000 shifted to support, rather than criminalize, largely students of color. CFJ Long Beach secured an eight-month contract with the Long Beach Unified School District to deepen and codify their equity practices in all their schools, working alongside youth to identify and strengthen relationship centered policies. CFJ Oakland deepened its relationship with the Oakland Unified School District to support and shift public perception to uplift and embrace youth leadership and decision making power. CFJ Fresno successfully teamed up with local organizers to delay budget decisions on school policing, focusing funds instead on student mental health and restorative justice. As part of our coalition work with the CA Partnership for the Future of Learning, CFJ ran a comprehensive needs assessment in April 2020 -- speaking with 600 students and families from low-income communities of color in more than 20 school districts -- to help school and district decisionmakers and community partners safely address school continuity and support for our students and families.

YO! Cali: In 2020, Youth Organize! California organized more than 50 convenings, peer exchanges, and training sessions, which strengthened the skills and capacities of 1,415 organizers and youth leaders from more than 90 organizations across California. YO! Cali launched the third year of its Emerging Organizers Fellowship program with 28 fellows from 27 organizations. Between April and June 2020, a committee of youth leaders from YO! Cali steering committee organizations led a process to create a Young Peoples Agenda Youth Demands Platform. In July 2020, approximately 450 youth leaders and organizers participated in a virtual Youth Power Assembly, during which youth leaders voted to prioritize issues for YO! Calis youth advocacy efforts and discussed issues and solutions with state-level decision-makers. YO! Cali played a lead role in helping to launch the Northern California Youth Organizing Funder Collaborative, a network of foundations and individual donors committed to creating more equitable, just, and effective social, economic, and political systems in the Greater San Francisco Bay Area. YO! Cali helped to establish the Southern California Youth Organizing Peer Learning Community with more than 25 youth organizations in the region.

Mobilizing for democracy: In May 2020, CFJ youth leaders played key roles in a youth rally held in May, attended by over 600 youth and allies from across the state, that centered the leadership of young people of color and elevated key issues requiring action in the leadup to the general election. During the 2020 general election season, CFJ helped co-lead the statewide Schools and Communities First campaign. Stakeholders at every level of the organization participated in a diverse range of voter outreach activities including regional field campaigns and weekly themed phone and text banks. We contacted more than 14,000 voters, of which we were able to ID 9,100 individuals who agreed that corporations should pay their fair share of taxes in California.
