 Community Engagement: Community Engagement served 894 unique community engagement and community wellness participants, including 155 Friendly Visitor matches (now Friendly Callers). Openhouse served 542 meals before the COVID-19 shutdown and conducted 1,739 intergenerational activity hours. Twelve emotional support groups moved on-line, supporting 235 group members. We also provided case management services to 74 community members. In lieu of the LGBT Pride Parade and our annual Fall Feast, staff and volunteers delivered 600 Pride bags during the 50th Anniversary of LGBT Pride Month in June, and 600 Give Thanks Baskets in November and December. 

 Housing: Openhouse Housing & Resource Navigation, serving the largest number of community members at 1,142 unique clients in 2020, conducted 24 housing workshops for 225 attendees, and held 123 individual counseling sessions. All workshops, counseling sessions and resource referrals are held on Zoom or by phone until further notice.

 Build-Out: Openhouse was very close to completion of its new Community Center at 75 Laguna Street in San Francisco when the COVID-19 pandemic struck. The 7100-sq.ft. facility will offer capacity for up to 5,000 community members per year. There are spaces for lifelong learning, art, social day programs, and evening gatherings for approximately 200.

Openhouse may periodically receive unrelated business income (such as sublease rental income or advertising revenue) requiring Openhouse to file separate tax returns under federal and state statutes.
