THE PROMISSORY NOTE CALLS FOR MONTHLY PRINCIPAL AND INTEREST PAYMENTS AMORTIZED OVER THE TWO-YEAR TERM OF THE PROMISSORY NOTE WITH A DEFERRAL OF PAYMENTS FOR THE FIRST SIX MONTHS. DURING THE YEAR ENDED DECEMBER 31, 2020, UPWARDLY GLOBAL USED THE PROCEEDS FOR PURPOSES CONSISTENT WITH THE PPP OVER THE 24-WEEK LOAN COVERED PERIOD FOLLOWING THE DISBURSEMENT OF FUNDS AND APPLIED FOR FORGIVENESS. ON FEBRUARY 24, 2021, UPWARDLY GLOBAL RECEIVED FORGIVENESS OF THEIR PPP LOAN BY THE SMALL BUSINESS ADMINISTRATION IN THE AMOUNT OF \$840,845. THERE ARE NO FURTHER REQUIREMENTS REGARDING THIS FUNDING AND UPWARDLY GLOBAL INTENDS TO RECORD THE AMOUNT FORGIVEN AS REVENUE FROM THE DEBT EXTINGUISHMENT DURING FISCAL YEAR 2021.
