COVID SIP issued in March, 2020 and curtailed scheduled activities. Educated 616 students (over 342,157 since 1990) grades K-college (in English & Spanish) with hands-on marine mammal programs with artifacts & activities. Bus field trips for 80 under-represented students and parent chaperones to the beach for outdoor field activities including water monitoring. Art project to decorate cloth shopping bags and protect waterways for 84 students. Provide service learning opportunities for 17 college students. Engaged 1,388 people through 40 public and community events: storm drain marking activities, waterway litter cleanups (over 1,000 pounds trash collected), recycling video with children, and outreach to garden stores regarding pesticide alternatives. Continued care of 5 monarch butterfly gardens to educate about the importance of using alternatives to pesticides. Implemented endangered species newspaper bin art project to raise awareness about local species and the connection between land and sea. Began adapting hands-on programs into distance learning programs for students. Assisted municipalities with storm drain pollution prevention outreach, and media campaigns. Partnerships on targeted issues with the whale disentanglement network, peninsula plastic pollution coalition, seafood watch program, respect wildlife coalition, saving the endangered vaquita. Stranding network resource to assist whales nationally and internationally. Provide educational website, social media, and e-newsletters on current marine mammal issues to assist whales local and worldwide.













