Explanation: On behalf of the Peace Resource Center of San Diego I am requesting relief from any penalties that may arise due to the late filing of the organization's 2020 Form 990. The following information chronicles the efforts made to submit the 2020 Form 990. On November 15, 2021 I attempted to follow the instructions for filing the enclosed Form 990 for 2020 electronically by opening an account with Form990Online, but the electronic submission was rejected by the IRS. After repeated efforts to submit electronically and calling the IRS Tax Exempt desk without getting a response, I resorted to mailing the Form 990 for 2020 to on November 20, 2021 with a cover letter explaining the situation in the hope that it would be accepted. I did not receive any response from the IRS until the 2020 Form 990 and my cover letter were returned to me by LTR 0422897269 dated May 05, 2022, advising me that the return must be submitted electronically, essentially putting me back to where I was in November 2021. I again attempted to file the 2020 Form 990 electronically on May 15, 2022, but again the return was rejected. I contacted the help desk at Form990Online and they again advised me to contact the IRS Tax Exempt desk. After calling the IRS Tax Exempt desk several times between May 23rd and May 25th, 2022, I was finally able to speak with Agent No. 1004011455, a Ms. Weiglein on May 25th. Agent Weiglein was able to determine that the number that had been assigned to the online account for Peace Resource Center of 95395424701 was incorrect. What I had failed to recognize is that the number recorded by Form990Online as the login id for the Peace Resource Center's account was the organization's FEIN with the digits 01 appended to it. This number was incorrect due to the 4th and 5th digits being reversed from Peace Resource Center's FEIN of 95-3594247. I acknowledge that this must have been an error on my part when I created the account for Peace Resource Center with Form990Online. With this information I requested Form990Online to create a new account for the Peace Resource Center, which they were able to do by June 10th. The delay in submitting the 2020 Form 990 was entirely due to my mistyping the FEIN for the Peace Resource Center when I opened the account with Form990Online. This was an innocent mistake on my part and I can assure was in no way an attempt to delay the filing of the return.
