WEV IS A COMMUNITY DEVELOPMENT FINANCIAL INSTITUTION (CDFI) AND PROVIDES MICRO ENTERPRISE LOANS OF UP TO \$25,000 TO STARTUPS AND BUSINESS EXPANSION LOANS OF UP TO \$150,000 TO PRE-BANKABLE BUSINESSES. WEV SERVES BOTH MEN AND WOMEN IN ALL PROGRAMS. IN 2020 WEV PROVIDED TRAINING AND TECHNICAL ASSISTANCE, INCLUDING 2,039 SESSIONS OF INDIVIDUAL CONSULTING TO 269 CLIENTS AND PROVIDED 74 MICRO LOANS TOTALING \$932,500.











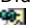
