CHAs collection is made up of artifacts, photographs, records, and remembrances of Coronados past that are held for exhibition and educational program activities. Each of the items is cataloged, preserved, and cared for, and activities verifying their existence and assessing their condition are performed continuously. The collection is maintained under the care of professional staff and is held for research, education, and public exhibition in furtherance of public service, rather than for financial gain.
