The Food Pantry distributes food to over 3,000 individuals, of whom approximately 50% are children. The Pantry receives a significant amount of donated services from unpaid volunteers who assist in program services and fundraising. The services are not specialized in nature and, therefore, do not meet the criteria for recognition as contributed services under FASB ASC NO. 958.
