TO PROTECT AND PRESERVE THE LIFEWAYS & CULTURE OF CHUMASH & INDIGENOUS PEOPLE & THE ENVIRONMENT.IN MARCH 2020, THERE WAS A GLOBAL OUTBREAK OF A NEW STRAIN OF CORONAVIRUS, COVID-19 AND THE GLOBAL AND DOMESTIC RESPONSE CONTINUE TO EVOLVE DURING THE YEAR WHICH ENDED DECEMBER 31, 2020. SEVERAL OF THE FOUNDATIONS PROGRAMS, SPECIFICALLY THOSE RELATED TO WORK WITH SCHOOL CHILDREN, WERE PAUSED, SOME STAFF WERE LAID OFF AND THE FOUNDATION WAS UNABLE TO HOST FUNDRAISING EVENTS. THE FOUNDATION, HOWEVER, CONTINUED ITS MISSION WORK OF ITS COMPREHENSIVE WATER MONITORING PROGRAM, AND RESTORING SOME OF THE HEAVILY DEGRADED ACREAGE WITH NATIVE PLANTS AND TREES INCLUDING, INDIGENOUS OAK TREES ALONG THE SANTA CLARA RIVER.
