Grantmaker's Description of How Grants are Used	Decision was made to provide PPE and Care Kits to our SRO buildings first because they share communal space like bathrooms and kitchens and due to the exposure of COVID in these communal spaces where social distancing was not always able to be practiced, we made sure those residents had proper PPE first. We then distributed PPE and Care Kits to our non-SRO buildings where residents have private studio apartments with their own bathroom and kitchen and were able to quarantine more successfully. The PPE typically was made up of disposable and reusable masks and personal hand sanitizer and on occasion we were able to provide disposable gloves, and face shields. The Care Kits consisted of toiletries like deodorant, toothbrush & toothpaste, body wash, shampoo/conditioner, face wash, socks, shower shoes, face & bath towel. The actual Supply Chain schedule was as follows: The first week of the month we would pick up/receive the donation, the second week of the month we would inventory and organize the donations, the third week of the month we would assemble PPE/Care Kits for each property, and the fourth week of the month PMO and HR would go into the field to distribute to the properties. We would include enough supplies to last each property one month, that included about 1,000 disposable masks, 200 reusable masks, and 200 hand sanitizers, we would also include 4 larger size hand sanitizers for communal areas. Each resident received one of every item in their Care Kit listed above (SRO and non-SRO) Care Kits were also distributed monthly. We had 27 properties operating at the time with 1800 residents living onsite during COVID. Cleaning supplies were donated as well and split up evenly among the properties and provided to the janitorial staff to increase the daily cleaning and sanitation by 3x.
