AFTER YEARS OF ADVOCACY, WE PLAYED A CRUCIAL ROLE IN THE EMMETT TILL & MAMIE TILL-MOBLEY HOME FINALLY BECOMING A RECOGNIZED AND PROTECTED DESIGNATED CHICAGO LANDMARK. FINAL STATUS WAS APPROVED FOR THE 15-BUILDING NEAR NORTH LANDMARK DISTRICT WHICH SAVED THE SUPERIOR STREET ROWHOUSES FROM DEMOLITION.
