WE ACCOMPLISH THIS BY: 1) ENVIRONMENTAL EDUCATION, 2) CONSERVATION SCIENCE, 3) ENVIRONMENTAL POLICY AND 4) LAND MANAGEMENT AND STEWARDSHIP. WE FULFILL THIS MISSION BY SETTING AND ACHIEVING ANNUAL GOALS IN ENVIRONMENTAL EDUCATION, CONSERVATION SCIENCE, ENVIRONMENTAL POLICY AND LAND MANAGEMENT ON OUR WILDLIFE SANTUARIES THROUGHOUT NEW HAMPSHIRE OUR SCIENCE RESEARCH INFORMS OUR STATEWIDE EDUCATION PROGRAMS IN GRADES K- 12 IN NH PUBLIC AND PRIVATE SCHOOLS AND FOR PEOPLE OF ALL AGES AT OUR CENTERS AND SANCTUARIES. WE PUBLISH OUR RESEARCH FOR THE BENEFIT OF OUR MEMBERS, BOTH NH STATE AND FEDERAL AGENCIES, OTHER ENVIRONMENTAL NONPROFIT PARTNERS AND THE GENERAL PUBLIC TO INCREASE AWARENESS OF THE IMPORTANCE OF BIRD AND OTHER WILDLIFE IN NEW HAMPSHIRE

THE DESCRIPTIONS AND NUMBERS BELOW IN SECTIONS 4A, 4B, AND 4C ARE REPRESENTATIVE OF THOSE IN A NORMAL YEAR FOR NH AUDUBON VS. THE LOWER COVID-19 NUMBERS EXPERIENCED DURING FY21. WE WERE, HOWEVER, ABLE TO OFFSET SOME OF THE FY21 LOST PHYSICAL PROGRAMMING VIA VIRTUAL EXPERIENCES. FORTUNATELY, WE OBTAINED SOME FINANCIAL OFFSETS FROM THE FEDERAL PPP1 & 2 PROGRAMS, A FEDERAL EIDL LOAN, THE NH STATE NHERF PROGRAM AND INCREASED SUPPORT FROM OUR DONOR BASE. NH AUDUBON (NHA) OPERATES THREE NATURE CENTERS: MCLANE (CONCORD), MASSABESIC (AUBURN), AND PARADISE POINT (HEBRON). THESE CENTERS SERVE AS THE FOCAL POINTS FOR THE MAJORITY OF OUR ENVIRONMENTAL EDUCATION AND OUTREACH PROGRAMMING. VISITORS CAN EXPERIENCE A VARIETY OF INTERACTIVE NATURE DISPLAYS ALONG WITH LIVE ANIMAL EXHIBITS AIMED AT INCREASING AWARENESS AND UNDERSTANDING ABOUT NEW HAMPSHIRE'S FLORA AND FAUNA WHILE HIGHLIGHTING THE ROLE HUMANS PLAY IN PROTECTING THEM. SURROUNDING THE CENTERS ARE WALKING TRAILS FOR THE PUBLIC TO ENJOY. OUR NATURE CENTERS HOST A WIDE VARIETY OF ONSITE EDUCATIONAL PROGRAMMING THAT INCLUDES PRESCHOOL CLASSES, HOME SCHOOL CLASSES, BOTH GUIDED AND SELF-GUIDED NATURE WALKS, PROFESSIONAL DEVELOPMENT OPPORTUNITIES FOR K-12 TEACHERS AND LECTURES THAT ANNUALLY REACH OVER 40,000 ADULTS AND CHILDREN. AS PART OF NHA'S OUTREACH, EACH CENTER OFFERS OFFSITE PROGRAMMING TO SCHOOLS, CAMPS AND OTHER ORGANIZATIONS THROUGHOUT THE STATE, OFTEN WITH THE USE OF LIVE ANIMALS INCLUDING RAPTORS, AMPHIBIANS AND REPTILES. OUR NATURALISTS DELIVER OVER 650 SCHOOL PROGRAMS EACH YEAR FACILITATING OVER 21,000 STUDENT EXPERIENCES. OUR SCHOOL PROGRAMS ARE ALIGNED WITH THE CURRENT NH STATE SCIENCE FRAMEWORK WITH AUGMENTS TRADITIONAL CLASSROOM INSTRUCTION BY PROVIDING HANDS-ON EXPERIMENTAL AND EXPERIENTIAL LEARNING OPPORTUNITES. ADDITIONALLY, THE MCLANE AND MASSABESIC CENTERS OPERATE NATURE-BASED SCHOOL VACATION AND SUMMER CAMPS WHICH ANNUALLY HOST OVER 300 CHILDREN RANGING FROM 4 TO 15 YEARS OF AGE. THIS PAST YEAR WAS A TRYING ONE FOR NHA AND ALL NON-PROFIT ORGANIZATIONS DUE TO THE COVID-19 ENVIRONMENT. WE WERE FORCED TO CLOSE OUR FACILITIES AS WELL AS CANCEL OUR CAMPS AND PROGRAMMING. ONE BIG IMPROVEMENT DURING THE YEAR WAS THE UPDATING OF OUR WEBSITE, SO CRITICAL IN TODAY'S WORLD, EXPECIALLY IN THE YEAR OF PHYSICAL SEPARATION. ADDITIONALLY, WE DEVELOPED AND DELIVERED DOZENS OF VIRTUAL EDUCATIONS PROGRAMS FOR SCHOOLS AS WELL AS PRESENTING EVENING WEBINARS, BOTH LIVE AND RECORDED, THROUGH MULTIPLE SOCIAL MEDIA PLATFORMS.

NHA OWNS AND MANAGES 39 WILDLIFE SANCTUARIES TOTALING NEARLY 7500 ACRES, MANAGES ANOTHER 4 PROPERTIES UNDER MEMORANDA OF UNDERSTANDING THAT TOTAL 1250 ACRES AND MONITORS THE CONSERVATION VALUE OF 26 EASEMENTS ON 2665 ACRES. NHA'S LAND STEWARDSHIP COVERS EVERY COUNTY IN NH WITH HABITATS RANGING FROM NORTHERN PEAT BOGS TO COASTAL SALT MARSHES AND FROM HIGH ELEVATION SPRUCE FORESTS TO APPALACHIAN OAK-HICKORY FORESTS WITH MUCH MORE IN BETWEEN. OUR SANCTUARIES PROTECT SEVERAL UNIQUE NATURAL COMMUNITIES THAT INCLUDE RATE PLANTS, BIRDS, MAMMALS, POLLINATORS AND OTHER THREATENED NATURAL WILDLIFE. IN 31 OF THESE PROPERTIES THERE ARE TRAIL SYSTEMS TOTALING 75 MILES OF MAINTAINED TRAILS. MANCY SANCTUARIES ARE HEAVILY VISITED FOR ENVIRONMENTAL EDUCATION AND LOW IMPACT RECREATIONAL USES. IN PARTICULAR, PONDICHERRY, PONEMAH BOG, MASSABESIC, SILK FARM, PARADIS POINT AND WILLARD POND WILDLIFE SANCTUARIES ARE VISITED ANNUALLY BY MORE THAN 20,000 INDIVIDUALS. A POSITIVE ASPECT OF THE CORONAVIRUS ENVIRONMENT THIS YEAR WAS THE DESIRE OF PEOPLE TO GET OUTDOORS WHILE SAFELY ENJOYING NATURE. OUR SANCTUARIES AND LAND HELPED FILL THIS NEED, EXPERIENCING CONSIDERABLE USAGE.









NHA IS ACTIVE IN CONSERVATION SCIENCE AND ENVIRONMENTAL POLICY ISSUES. OUR CONSERVATION SCIENCE WORK INCLUDES RESEARCH, MONITORING AND MANAGEMENT OF NEW HAMPSHIRE'S WILDLIFE, PARTICULARLY SPECIES OF CONCERN. IN THE PAST YEAR THERE CONTINUED TO BE A STRONG FOCUS ON RAPTORS AND AERIAL INSECTIVORE RESEARCH. A MAJOR ACCOMPLISHMENT THIS YEAR WAS THE PUBLICATION OF THE STATE OF NEW HAMPSHIRE'S BIRDS WHICH IS PART OF AN EVERY - 10 YEAR LONGITUDINAL STUDY OF THE CHANGES IN NH'S BIRD SPECIES POPULATIONS. WHILE MANY PROJECTS DO FOCUS ON BIRDS, OUR WORK GOES WELL BEYOND AVIAN SPECIES. RECENT STUDIES HAVE INCLUDED BATS, DRAGONFLIES, BUTTERFLIES AND TURTLES. WE ARE ACTIVE IN HELPING TO IMPLEMENT THE EXCITING MOTUS TRACKING SYSTEM, WITH PARTNERS, IN THE NORTHEAST TO MONITOR MIGRATION PATTTERS FOR A VARIETY OF AERIAL WILDLIFE RANGING FROM BIRST TO BATS TO BUTTERFLIES ALONG WITH OTHER WILDLIFE SPECIES. WE ENGAGE A LARGE CADRE OF CITIZEN SCIENTISTS IN OUR WORK. APPROXIMATELY 2100 VOLUNTEERS CONTRIBUTE OVER 17,400 HOURS ANNUALLY. WHILE VOLUNTEER HOURS WERE DOWN THIS YEAR DUE TO COVID-19, THERE WAS STILL MUCH FIELDWORK THAT COULD BE SAFELY DONE. NHA'S ADVOCACY WORK PROMOTES SCIENCE-BASED PUBLIC POLICY AT NATIONAL, STATE AND LOCAL LEVELS. AN ENVIRONMENTAL POLICY COMMITTEE COMPOSED OF BOTH STAFF AND VOLUNTEERS DETERMINES OUR POSITIONS ON PROPOSED LEGISLATION AND DELIVERS TESTIMONY AT HEARINGS. STAFF MEMBERS REPRESENT THE ORGANIZATION IN VARIOUS STATE POLICY WORKING GROUPS AND TECHNICAL COMMITTEES AS WELL AS PARTICIPATE IN STATE AND REGIONAL COALITIONS. NHA COLLABORATES WITH OTHER NONPROFIT, STATE AND LOCAL AGENCIES, ACADEMIC INSTITUTIONS, MUNICIPALITIES AND BUSINESSES. WE RESPECT OUR COLLATORATORS' PERSPECTIVES WHILE ADVOCATING THE BEST POSSIBLE ENVIRONMENTAL OUTCOMES. OUR CURRENT EXAMPLE OF THE ABOVE FOR NHA STAFF IS THE PREVIOUSLY MENTIONED THE STATE OF NEW HAMPSHIRE'S BIRDS. THIS PUBLICATION IS A GOOD EXAMPLE OF STAFF WORK THAT CAN BE USED FOR BOTH POLICY AND LEGISLATION. IT IS DATA- BASED, ILLUSTRATES SPECIES DOING WELL OR IN TROUBLE AND OUTLINES ACTIONS THAT CAN BE TAKEN WHERE NEEDED.

AS PART OF NHA'S OUTREACH, EACH CENTER OFFERS OFFSITE PROGRAMMING TO SCHOOLS, CAMPS AND OTHER ORGANIZATIONS THROUGHOUT THE STATE, OFTEN WITH THE USE OF LIVE ANIMALS INCLUDING RAPTORS, AMPHIBIANS AND REPTILES. OUR NATURALISTS DELIVER OVER 650 SCHOOL PROGRAMS EACH YEAR FACILITATING OVER 21,000 STUDENT EXPERIENCES. OUR SCHOOL PROGRAMS ARE ALIGNED WITH THE CURRENT NH STATE SCIENCE FRAMEWORK WITH AUGMENTS TRADITIONAL CLASSROOM INSTRUCTION BY PROVIDING HANDS-ON EXPERIMENTAL AND EXPERIENTIAL LEARNING OPPORTUNITES. ADDITIONALLY, THE MCLANE AND MASSABESIC CENTERS OPERATE NATURE-BASED SCHOOL VACATION AND SUMMER CAMPS WHICH ANNUALLY HOST OVER 300 CHILDREN RANGING FROM 4 TO 15 YEARS OF AGE. THIS PAST YEAR WAS A TRYING ONE FOR NHA AND ALL NON-PROFIT ORGANIZATIONS DUE TO THE COVID-19 ENVIRONMENT. WE WERE FORCED TO CLOSE OUR FACILITIES AS WELL AS CANCEL OUR CAMPS AND PROGRAMMING. ONE BIG IMPROVEMENT DURING THE YEAR WAS THE UPDATING OF OUR WEBSITE, SO CRITICAL IN TODAY'S WORLD, ESPECIALLY IN THE YEAR OF PHYSICAL SEPARATION. ADDITIONALLY, WE DEVELOPED AND DELIVERED DOZENS OF VIRTUAL EDUCATIONS PROGRAMS FOR SCHOOLS AS WELL AS PRESENTING EVENING WEBINARS, BOTH LIVE AND RECORDED, THROUGH MULTIPLE SOCIAL MEDIA PLATFORMS.

OUR SANCTUARIES PROTECT SEVERAL UNIQUE NATURAL COMMUNITIES THAT INCLUDE RARE PLANTS, BIRDS, MAMMALS, POLLINATORS AND OTHER THREATENED NATURAL WILDLIFE. IN 31 OF THESE PROPERTIES THERE ARE TRAIL SYSTEMS TOTALING 75 MILES OF MAINTAINED TRAILS. MANCY SANCTUARIES ARE HEAVILY VISITED FOR ENVIRONMENTAL EDUCATION AND LOW IMPACT RECREATIONAL USES. IN PARTICULAR, PONDICHERRY, PONEMAH BOG, MASSABESIC, SILK FARM, PARADIS POINT AND WILLARD POND WILDLIFE SANCTUARIES ARE VISITED ANNUALLY BY MORE THAN 20,000 INDIVIDUALS. A POSITIVE ASPECT OF THE CORONAVIRUS ENVIRONMENT THIS YEAR WAS THE DESIRE OF PEOPLE TO GET OUTDOORS WHILE SAFELY ENJOYING NATURE. OUR SANCTUARIES AND LAND HELPED FILL THIS NEED, EXPERIENCING CONSIDERABLE USAGE.

WE ARE ACTIVE IN HELPING TO IMPLEMENT THE EXCITING MOTUS TRACKING SYSTEM, WITH PARTNERS, IN THE NORTHEAST TO MONITOR MIGRATION PATTERS FOR A VARIETY OF AERIAL WILDLIFE RANGING FROM BIRST TO BATS TO BUTTERFLIES ALONG WITH OTHER WILDLIFE SPECIES. WE ENGAGE A LARGE CADRE OF CITIZEN SCIENTISTS IN OUR WORK. APPROXIMATELY 2100 VOLUNTEERS CONTRIBUTE OVER 17,400 HOURS ANNUALLY. WHILE VOLUNTEER HOURS WERE DOWN THIS YEAR DUE TO COVID-19, THERE WAS STILL MUCH FIELDWORK THAT COULD BE SAFELY DONE. NHA'S ADVOCACY WORK PROMOTES SCIENCE-BASED PUBLIC POLICY AT NATIONAL, STATE AND LOCAL LEVELS. AN ENVIRONMENTAL POLICY COMMITTEE COMPOSED OF BOTH STAFF AND VOLUNTEERS DETERMINES OUR POSITIONS ON PROPOSED LEGISLATION AND DELIVERS TESTIMONY AT HEARINGS. STAFF MEMBERS REPRESENT THE ORGANIZATION IN VARIOUS STATE POLICY WORKING GROUPS AND TECHNICAL COMMITTEES AS WELL AS PARTICIPATE IN STATE AND REGIONAL COALITIONS. NHA COLLABORATES WITH OTHER NONPROFIT, STATE AND LOCAL AGENCIES, ACADEMIC INSTITUTIONS, MUNICIPALITIES AND BUSINESSES. WE RESPECT OUR COLLATORATORS' PERSPECTIVES WHILE ADVOCATING THE BEST POSSIBLE ENVIRONMENTAL OUTCOMES. OUR CURRENT EXAMPLE OF THE ABOVE FOR NHA STAFF IS THE PREVIOUSLY MENTIONED THE STATE OF NEW HAMPSHIRE'S BIRDS. THIS PUBLICATION IS A GOOD EXAMPLE OF STAFF WORK THAT CAN BE USED FOR BOTH POLICY AND LEGISLATION.
