Family Camp: A total of 116 participants took part in two Family Camps held in July 2021 at YMCA Camp Loma Mar. Additionally, a total of 9 Nature Day Outings and 2 kayaking trips were conducted for 311 family members at local regional parks during Fall 2020 and Spring 2021.

4b (Code:) (Expenses \$ **236,500** including grants of \$ **10,130**) (Revenue \$)

Camp-to-Community: 26 teens were actively engaged in the Camp-to-Community (C2C) program. 11 of these teens completed the Youth Engagement Team cohort which included an assessment and study of Nichol Park to make health and wellness improvements and led activities during Nature Day Outings. Nine youth participated in the Climate Conservation Cohort (C3) studying the impact of climate change in marine environments. Youth participated in day and overnight hiking and backpacking trips during Summer 2021.

Young Adult Program: 6 youth completed the first cohort of the Young Adult Program which launched in 2020. A full-time specialist was hired to run the program which included virtual and in-person meetings to examine substance abuse and the war on drugs, community prevention, leadership practices, and policy change.
