IN 1986, THE SOCIETY SOUGHT TO EXPAND ITS MISSION DELIVERY AND PURCHASED A DAIRY FARM IN BOYLSTON THAT BECAME TOWER HILL BOTANIC GARDEN (THBG). TODAY, THBG IS A DYNAMIC FOUR-SEASON HORTICULTURAL SHOWCASE WITH 171 ACRES OF GROUNDS, 16 ACRES OF DEVELOPED GARDENS, TWO OFF-SEASON CONSERVATORIES HOUSING MORE THAN 1,000 PLANTS, AND MILES OF TRAILS THROUGH FOREST AND FIELD. WE ARE A GARDEN FOR ALL, WELCOMING EVERY WORCESTER SECOND GRADER AS PART OF THE CITY'S CURRICULUM, DEVELOPING ACCESSIBLE GARDENS THAT WELCOME GUESTS WITH A VARIETY OF ABILITIES AND IMPLEMENTING PROGRAMS SUCH AS OUR FREE SUMMER EVENINGS TO WELCOME A DIVERSE AUDIENCE TO OUR PROPERTY.
