IN 2021, CEP CONDUCTED RESEARCH ON HOW NONPROFITS WERE EXPERIENCING CONSEQUENCES OF THE COVID-19 PANDEMIC AS WELL AS CHANGES FOUNDATIONS MADE AS A RESULT OF THE PANDEMIC AND INCREASING CALLS FOR RACIAL JUSTICE.
