Forgotten VoicesEnvironmental injustices are complex issues that not only sit at the intersection of class and race, but also need to be examined and approached at every level of government: federal, state, county and city. In addition to the environmental and health impacts of polluting industries, environmental justice communities in California also deal with a lack of infrastructure and access to resources. Historically, City and County governments have used local land use policies to racially segregate communities through redlining which restricted where people of color could own property. Often these areas were within or next to areas zoned for industrial use, designated for highway construction, or for waste disposal. Leadership Development/Movement BuildingCRPE is unique in how we carry out our mission of achieving environmental justice and healthy sustainable communities because of our model to develop of community leaders and grassroots organizations along at a local level, along with building power at the state and national level. Locally, we our programs build the individual capacity of community residents, foster community power vis--vis decision-makers and address the environmental issues facing the community. We combine community education, community organizing, legal representation and policy advocacy to assist communities facing environmental harms such as climate change, oil extraction, industrialized agriculture, air quality issues and toxic waste siting. We address these issues by focusing on the racial, social and economic inequities of climate change and by prioritizing local solutions to this global problem.CRPE uses its unique blend of community organizing, litigation and policy advocacy to address the dual threats that low-income communities and communities of color face: disproportionately suffering from the effects of climate change, and the effects of policy decisions to address global warming. We have a three prong approach to our community investment and land us work:* Reducing pollution in communities by improving water quality, preventing the siting of polluting industries, or mitigation pollution of existing facilities.* Working with community members to develop an equitable vision for their communities as reflecting in long-range plans such as General Plans.* Attracting funding for community-driven projects that are consistent with the communitys long-term vision.Climate Justice (continued from Form 990 Page 2)Currently our climate justice work focuses on working with communities in the San Joaquin Valley to transition to clean energy based economies, in particular ending extreme oil and gas extraction (including fracking) in California, addressing the impact of short-lived climate pollutants such methane on our environment, and advocating for direct regulations and an equitable carbon pricing system at the state level.We also include sustainable agricultural work in this work as well as it related to dairies. Californias industrial-style, factory farm dairy industry began a rapid expansion in the 1990s and now is one of the leading air, climate, and groundwater polluters in the San Joaquin Valley. After Arvin residents asked for help in 1998, CRPE launched our dairy work by stopping several, massive dairy proposals. Working with communities, CRPE has made a huge impact on this problem by successfully forcing transparency and accountability, ending an agricultural exemption for air quality controls, and working to impose the most stringent air pollution controls in the United States.Leadership Development/Movement Building (continued from Form 990 Page 2)Valley where the poorest residentsprimarily Latino farmworkers and recent immigrantsare most at risk. Our work is rooted in the San Joaquin Valley because it is one of the poorest and most environmentally unhealthy regions of the country, and also because what happens here affects the nation.Environmental justice advocacy is traditionally undertaken on a local scale with advocates working alongside residents to defeat an environmental threat, while not directly addressing the systemic causes of environmental injustices. CRPE is flipping this model to scale-up grassroots organizing and advocacy to challenge the power systems that lead to inequalities in the first We currently work closely with and support several community groups in the San Joaquin Valley including:* Committee for a Better Arvin* Committee for a Better Shafter* Delano Guardians* Greenfield Walking Group* Comite Progreso de LamontAlong with building grassroots leadership, we also partner with groups at the state and national levels and participate in several coalitions including the California Environmental Justice Alliance and Californians Against Fracking.
