IN FY2021, EDF FOCUSED MUCH OF THIS WORK ON TWO OF THE BIGGEST OPPORTUNITIES TO MAKE AN IMPACT: METHANE POLLUTION FROM OIL AND GAS OPERATIONS; AND THE TRANSPORTATION SECTOR. OUR 2021 REPORT ON METHANE POLLUTION FOUND THAT CONCERNED GLOBAL ACTION, USING EXISTING TECHNOLOGIES, COULD CUT METHANE POLLUTION IN HALF BY 2030 AND SLOW THE RATE OF GLOBAL WARMING BY AS MUCH AS 30%. THESE FINDINGS WERE ECHOED IN A LANDMARK UNITED NATIONS ASSESSMENT IN MAY AND, SOON AFTERWARD, THE UN INTERGOVERNMENTAL PANEL ON CLIMATE CHANGE UNDERScoreD THE NEED TO SLASH METHANE. IN SEPTEMBER, THE EU AND U.S. AGREED TO CUT METHANE EMISSIONS FROM MAJOR SOURCES AT LEAST 30% BY 2030; ULTIMATELY MORE THAN 100 COUNTRIES SIGNED THE PLEDGE. IN THE U.S., WE HELPED BUILD BIPARTISAN SUPPORT TO REINSTATE REGULATIONS TO REDUCE METHANE POLLUTION FROM NEW OIL AND GAS FACILITIES, WHICH ENABLED THE EPA TO THEN EXPAND THOSE RULES TO COVER, FOR THE FIRST TIME, THE ROUGHLY 800,000 OLDER WELLS THAT ACCOUNT FOR THE BULK OF THE INDUSTRY'S METHANE POLLUTION. IN THE TRANSPORTATION SECTOR, EDF HELPED BUILD INDUSTRY CONSENSUS AROUND THE ADMINISTRATION'S GOAL OF MAKING HALF OF ALL NEW PASSENGER VEHICLES SOLD IN THE U.S. ZERO-EMISSION BY 2030. WE HELPED LEAD GENERAL MOTORS TOWARD ANNOUNCING IT WOULD SELL ONLY ZERO-EMISSION VEHICLES BY 2035, AND WE WORKED CLOSELY WITH FORD, WHICH HAS SAID THAT 40-50% OF ITS GLOBAL SALES WILL BE ELECTRIC BY 2030. OUR CORPORATE PARTNERSHIPS ARE ALSO HELPING TO REDUCE CLIMATE POLLUTION. WE ARE WORKING WITH COMPANIES LIKE IKEA AND FEDEX, BOTH OF WHICH HAVE COMMITTED TO MAKING THEIR DELIVERIES POLLUTION-FREE, AND WITH MAJOR INVESTORS, INCLUDING LEGAL AND GENERAL INVESTMENT MANAGEMENT AMERICA, TO PUSH MAJOR TRANSPORTATION AND OIL AND GAS COMPANIES, INCLUDING EXXONMOBIL, TO RAPIDLY TRANSITION TO NET ZERO EMISSIONS.

WE ARE ALSO ENGAGED IN ADVANCING COASTAL RESILIENCE PROJECTS IN NEW YORK, NEW JERSEY, TEXAS AND VIRGINIA.
