IN THE SUMMER OF 2020 A SPECIAL ON-LINE DANCE WAS CREATED ON THE COMPANY BY CHOREOGRAPHER LARRY KEIGWIN. NEW WORKS BY CHOREOGRAPHERS LAUREN LOVETTE, PETER CHU AND MICHELLE MANZANELES CONTINUED EVEN DURING THE PANDEMIC, WITH STRICT COVID PROTOCOLS IN PLACE. THE LICENSING OF PAUL TAYLOR CHOREOGRAPHY BY PAUL TAYLOR CONTINUED DESPITE THE PANDEMIC, WITH ON-LINE STAGINGS VIA ZOOM.

IN ADDITION, THERE WERE PERFORMANCES PRESENTED VIRTUALLY IN DENVER AND IN POTSTAM, NY.
