IN 2021, THE MARKET CITIES TEAM UNDERWENT EXTENSIVE PROGRAM AND BUSINESS PLANNING FOR THE NEWLY FORMALIZED PROGRAM. THIS PLANNING INCLUDED RESEARCH AND DEVELOPMENT OF A MENU OF ACTIVITIES TO OFFER IN THE COMING YEARS, INCLUDING ON-THE-GROUND PROJECTS, TRAININGS, CONFERENCES, NETWORKING ACTIVITIES, AND COMMUNICATIONS. ON OCTOBER 17, 2021 MARKET CITIES LAUNCHED A BRAND-NEW WEBSITE AND BI-WEEKLY E-NEWSLETTER. THE WEBSITE IS THE ONLINE HOME OF MARKET CITIES WHERE VISITORS CAN LEARN MORE ABOUT THE PROGRAM'S MISSION, VISION, SERVICES; READ ORIGINAL ARTICLES ON THE GLOBAL PUBLIC MARKETS FIELD; AND STAY UP-TO-DATE ON EVENTS AND OPPORTUNITIES BEING OFFERED BY PROJECT FOR PUBLIC SPACES. IN THE REMAINING MONTHS OF 2021, TWO ARTICLES WERE PUBLISHED ON THE WEBSITE, FIVE E-NEWSLETTERS WERE RELEASED, AND MARKET CITIES RELEASED A "REQUEST FOR INTEREST" TO HOST THE 11TH INTERNATIONAL PUBLIC MARKETS CONFERENCE IN 2023, RECEIVING SIX SUBMISSIONS. PLANNING AND PREPARATION ALSO BEGAN FOR PROJECT FOR PUBLIC SPACES' FIRST ONLINE "HOW TO CREATE SUCCESSFUL MARKETS" TRAINING, WHICH WAS HELD IN MARCH 2022.
