THE NEW PRESS POSTED STRONG RESULTS IN 2021, OUTPERFORMING BOTH BUDGET AND FORECAST. THIS WAS ACHIEVED DESPITE SIGNIFICANT CHALLENGES WITH BOTH FRONTLIST PERFORMANCE AND SUPPLY CHAIN ISSUES. ALTHOUGH THERE WAS NOT A REPEAT OF THE STRATOSPHERIC SALES REVENUES WE ENJOYED IN 2020, OUR NUMBERS WERE BOOSTED BY HIGH SELL-THOUGH, AN ENDURING BACKLIST WITH AWARD-WINNING TITLES THAT CONTINUE TO RESONATE WITH READERS, A HANDFUL OF STRONG FRONTLIST TITLES (EXCEPT FOR PALESTINE, KAEPERNICK EFFECT, ATLAS OF DISAPPEARING PLACES), AND UNPRECEDENTED CONTRIBUTED REVENUES. BOTH EARNED AND CONTRIBUTED REVENUES SOARED ABOVE FORECAST. THE NEW PRESS CONTINUED TO IMPROVE ITS LIQUIDITY WITH CASH ON HAND OVER \$4.M AT THE END OF 2021.
