OVER THE PAST 19 YEARS, STORYCORPS PROVIDED MORE THAN 600,000 PEOPLE FROM ALL 50 UNITED STATES WITH VITAL OPPORTUNITIES TO RECORD INTERVIEWS ABOUT THEIR LIVES, PASS WISDOM FROM ONE GENERATION TO THE NEXT, AND LEAVE A LEGACY FOR THE FUTURE IN ITS ARCHIVE AT THE AMERICAN FOLKLIFE CENTER AT THE U.S. LIBRARY OF CONGRESS.
