In 2021 BtGA surveyed, designed, and constructed a 30 meter suspension bridge at Olare Motorogi, surveyed and designed a 40 meter suspension bridge for Olerkesi, and designed a 45 meter suspension bridge for Baraka Camp. BtGA also surveyed two sites in Bungoma County as well as a site for a proposed bridge at Olare Orok. In addition, we repaired the Oltuleile Bridge, two bridges at Mara, as well as fabricated a replacement metal deck for Luca's Crossing. We also inspected the mara Intrepids bridge and completed design for a wall at KMTI. During the year BtGA began community engagement in Wakor and conducted online lectures for Hulman Institute of Technology.
