THESE SERVICES INCLUDE DAILY STORYTIME PROGRAMS, VISUAL ARTS AND DRAMA PROGRAMS, MENTORING AND COUNSELING INCLUDING HIV/AIDS PREVENTION PROGRAMS, OUTREACH, AND USE OF COMPUTERS AND COMPUTER-BASED LITERACY LESSONS IN ZAMBIAN LANGUAGES.
