RESTRICTIONS AROUND COVID-19 SHIFTED EDUCATION PROGRAMMING ONLINE IN SPRING AND SUMMER 2020 WITH THE CREATION OF MATERIALS AVAILABLE TO STUDENTS OF ALL AGES THROUGH OUR SOCIAL MEDIA PLATFORMS AND WEBSITE.
