Each year, more than 8,000 people of all ages experience field trips, community events, camps, workshops, private gatherings, and other activities. The Staff and Board of Directors are responsible for strategic planning, fundraising, program development and implementation, outreach, and community engagement. Approximately 300 volunteers assist annually with programs and site upkeep.
