Grants-to-Clubs help schools start new Outing Clubs and assists established clubs in strengthening their programs. We award grants of outdoor gear or cash up to \$500. 6 grants were awarded in 2020 to support club travel to outings, first aid training, and new equipment such as camp kitchens. This is a significant reduction in the normal demand for financial assistance since COVID prevented many off campus outings from taking place.
