IT WORKS WITH POLICYMAKERS ON INTERNATIONAL, REGIONAL, NATIONAL AND LOCAL LEVELS; SCHOLARS AND RESEARCHERS; AND COMMUNITY-BASED ORGANIZATIONS. ITS WORK PARTICULARLY FOCUSES ON UNDOCUMENTED IMMIGRANTS, REFUGEES, IMMIGRANT DETAINEES, AND OTHER AT-RISK POPULATIONS. IT SEEKS TO LIFT UP THE INSIGHTS AND AGENCY OF THESE COMMUNITIES.
