Achievements during the 2020-2021 school year included services to 3540 students 985 were outfitted, 1220 books were provided to community clinics, 90 kindergarten backpacks, 600 masks to a local school, and 645 participated in poetry writing and other enrichment art programs.

Due to the Coronavirus pandemic, these activities was limited during the year ended May 31, 2021. The program served 219 individuals by providing baby layettes, highchairs and gift bags and gift cards. During the year ended May 31, 2021, five scholarships and two laptops were awarded for a total of \$4,533.
