HEALTH PROMOTION:SOPHE LEADS MANY HEALTH PROMOTION INITIATIVES WHICH CONTRIBUTE TO THE GLOBAL EFFORT TO IMPROVE PUBLIC HEALTH OUTCOMES AND ACHIEVE HEALTH EQUITY. THE INITIATIVES INCLUDE PROGRAMS TO TRAIN STUDENTS AND PROFESSIONALS ON THE CONNECTIONS BETWEEN BEHAVIORAL SCIENCES, HEALTH EDUCATION, HEALTH PROMOTION AND THE ENVIRONMENT. SOPHE ALSO WORKS WITH OTHER NATIONAL ORGANIZATIONS, FEDERAL AGENCIES, BUSINESSES, HOSPITALS, SCHOOLS, AND LOCAL COMMUNITIES TO ADDRESS HEALTH INEQUITY, TO IMPROVE THE HEALTH OF COMMUNITIES BY REDUCING CHRONIC DISEASE RISKS DUE TO POOR NUTRITION, PHYSICAL INACTIVITY, TOBACCO USE AND OTHER LIFESTYLE RISK FACTORS. SOPHE ALSO PROVIDES TRAINING TO HEALTH PROVIDERS TO HELP PREGNANT WOMEN QUIT SMOKING. SOPHE'S WORK INCLUDES SUPPORTING UNDERGRADUATE STUDENTS TO PURSUE A CAREER IN PUBLIC HEALTH, INCREASE STUDENT HEALTH OUTCOMES AND INSTRUCTION.SOPHE'S COOPERATIVE AGREEMENT WITH THE CENTERS FOR DISEASE CONTROL AND PREVENTION PROJECTS INCLUDED A SERIES OF THREE ONE-HOUR WEBINARS LED BY JOURNAL EXPERTS FROM THE CDC AND EDITORIAL BOARD MEMBERS FROM SOPHE'S JOURNALS. THESE WEBINARS WERE OPEN TO ALL CDC DIVISION OF NUTRITION, PHYSICAL ACTIVITY AND OBESITY (DNPAO) GRANTEEES AND SOPHE MEMBERS. SOPHE AND THE CDC'S DNPAO HELD TWO VIRTUAL WRITING FOR PUBLICATIONS WORKSHOPS; CHARLES BROWN, DIRECTOR OF EQUITABLE CITIES, CONDUCTED NINE INTERVIEWS WITH BLACK SCHOLARS AND THOUGHT LEADERS ACROSS THE U.S. TO BETTER UNDERSTAND THE HISTORICAL CONTEXT, THE BARRIERS, AND CONSEQUENCES OF RACIAL INEQUITIES THAT DISCOURAGE PHYSICAL ACTIVITY AMONG BLACK INDIVIDUALS AND COMMUNITIES. IN MARCH OF 2021, AN ENVIRONMENTAL LITERATURE SCAN WAS CONDUCTED ON SOPHE'S BEHALF BY DR. TYLER PROCHNOW. THE SCAN FOCUSED ON THE PEDESTRIAN, BICYCLE, AND PUBLIC TRANSPORTATION SYSTEMS CONNECTED TO ENVIRONMENTS OR LAND USE TOPICS, INCLUDING POLICY, SYSTEM, AND ENVIRONMENTAL CHANGES THAT CAN PROMOTE OR DISCOURAGE EQUITABLE AND INCLUSIVE ACCESS TO PHYSICAL ACTIVITY, SPECIFICALLY ACTIVITY-FRIENDLY ROUTES TO EVERYDAY DESTINATIONS. IN TOTAL, 33 PEER-REVIEWED ARTICLES, 99 GREY LITERATURE RESOURCES, AND 6,324 TWEETS WERE ANALYZED FOR THIS SCAN. THE END REPORT, "INTERVIEWS WITH BLACK SCHOLARS IN TRANSPORTATION, PUBLIC HEALTH, AND LAND USE," HIGHLIGHTS THE THEMES AND CONCEPTS THAT AROSE FROM THE ENVIRONMENTAL SCAN.
