Community Living Arrangements - Goodwill operates thirteen group homes in Luzerne and Lackawanna Counties. These homes provide a safe living environment for individuals who are intellectually and developmentally disabled and unable to live independently. The staff assists each resident with daily activities such as proper hygiene, monitoring medications, money management and community integration. Each individual is encouraged to live a full life respected by others and supported by everyone.

4b (Code:) (Expenses \$ **650,976** including grants of \$) (Revenue \$)
Community Participation Support CPS - Goodwill offers several different programs such as CPS, S.E.A.L., which is an after school and summer program for children ages 10 to 16 Community Options, designed to provide social and recreational activities through community inclusiveness and Choose Your Future for high school and out of school youth transitioning into the workforce.

4c (Code:) (Expenses \$ **781,368** including grants of \$) (Revenue \$)
Community Employment - Goodwill provides hands-on job training to those facing barriers to employment, such as physical and/or intellectual disabilities, incarceration and dependencies. Along with our Job Coaches the participants gain training in interviewing skills, proper hygiene, dress code and other areas of job readiness. The jobs pay the same wage and benefits received by other employees. The Employment Specialist/Job Coach accompanies participants to their job and actively involves themselves in job training on all aspects of the job to ensure satisfactory performance. The Employment Specialist/Job Coach decreases work hours as the job tasks are mastered. Goodwill Retail Stores play a vital role in the delivery of this mission service.
